PRETTY FACE ON CORPORATE CAPTURE EVEN IN THE UNITED NATIONS.

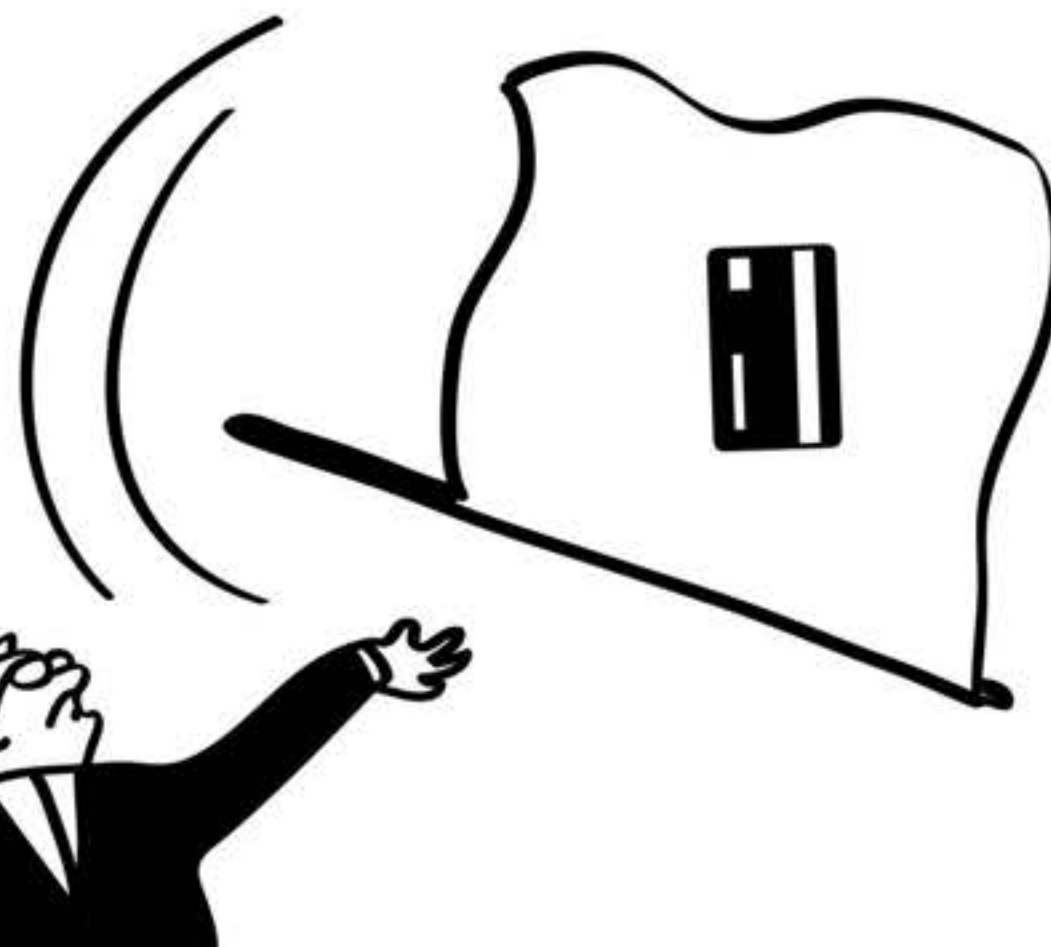




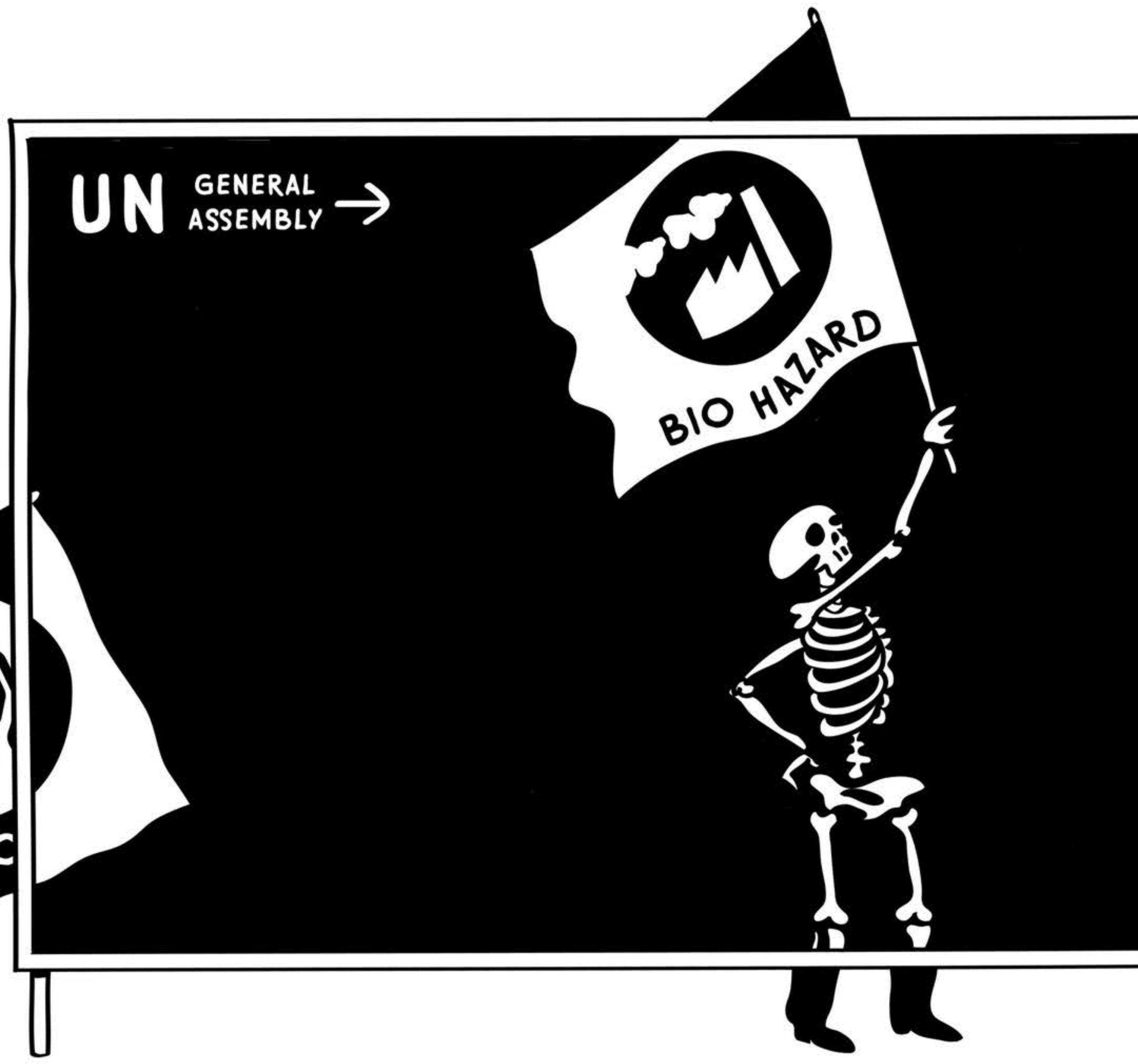
